# CONFERENCE HIGHIGHTS





- In Person at Creighton University Mike & Josie Harper Center
- Over 90 attendees present
- Friday included: Free Student Session, 2 unopposed Pre-Institute Sessions, 1 keynote
- Saturday participants attended one of 3 morning sessions and one of 3 afternoon sessions

- Sessions are now LIVE for purchase on <u>Aspire OT!</u>





- LB 430, which aims to prevent the application of the Multiple Procedure Payment Reduction strategy to private insurance, advanced out of committee during a tumultuous legislative session
- NOTA worked with the Applied Behavioral Analysis practice act establishment to ensure clarity of roles between OT and ABA, as well as to comment on recommendations for supervision of RBTs
- Despite significant and collaborative effort, Nebraska's helmet law was repealed, and modified to allow riders over the age of 21 to choose not to wear a helmet.
- 50+ meetings with senators, representatives, payer groups, and associations occured
